### REPORTS OF OFFICERS, BOARDS AND COMMITTEES:

- a. <u>Library Report</u> –Library minutes of May 11, 2022 were contained in City Council packets was reviewed and approved. Jeff Ommert made the motion, seconded by Tony Groshong, to approve the Library Minutes. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf, absent and not voting were Derek Raburn and Vernita Saylor; none voted no. Motion carried unanimously by City Council Members present.
- b. <u>Utility Supervisor Report</u> Dave Houghtelling reported on the following: Capacitors to the Ethanol Plant were not working for 6 days and the Ethanol Plant would usually be charged a penalty, however, if the issue is resolved by June the penalty will be waived. Twin Valley's Public Power District has shown interest in purchasing the Line truck in January 2023. City Attorney Lisa Shifflet will draw an agreement for the purchase of the truck to Twin Valley's. The exterior of the bathrooms at the South Park Restrooms has been painted and showers have been updated with hot water. Dave has been spraying weeds.
- c. <u>City Clerk/Treasurer</u> Kandra Kinne reported that there will be a new email for the City Clerk and Melissa Jackson will add to the City of Cambridge website. It was brought to the council's

attention that two contracts in the Harvest Meadows subdivision have no sidewalks and one contract does have a sidewalk and is zoned for commercial, no action will be needed. Kandra will continue to work with City Attorney Lisa Shifflet on what to do for cash only customers. Nebraska Tax Advantage sales tax refund report was included for review. Kandra and Courtney will be attending finance conference next week.

### **NEW BUSINESS:**

- a. Hojo's Hideaway Special Designated Liquor Permit for July 16, 2022 at the community building for a wedding. Tony Groshong stated the motion, seconded by Mike Harris to approve the Special Designated Liquor Permit at the Cambridge Community Building for July 16, 2022. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf, absent and not voting were Derek Raburn and Vernita Saylor; none voted no. Motion carried unanimously by City Council Members present.
- b. Hojo's Hideaway Special Designated Liquor Permit for July 23, 2022 at the community building for Werkmeister fundraiser. Mike Harris stated the motion, seconded by Tony Groshong to approve the Special Designated Liquor Permit at the Cambridge Community Building for July 23, 2022. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf, absent and not voting were Derek Raburn and Vernita Saylor; none voted no. Motion carried unanimously by City Council Members present.
- c. Amateur's Special Designated Liquor Permit for June 24, 2022 at the community building. Jeff Ommert stated the motion, seconded by Mike Harris to approve the Special Designated Liquor Permit at the Cambridge Community Building for June 24, 2022 Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf, absent and not voting were Derek Raburn and Vernita Saylor; none voted no. Motion carried unanimously by City Council Members present.
- d. Permit to keep chickens Abby Schulte's permit to keeps chickens at 816 Pacific St was approved. Tony Groshong stated the motion, seconded by Mike Harris. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf, absent and not voting were Derek Raburn and Vernita Saylor; none voted no. Motion carried unanimously by City Council Members present.

#### e. Cross Creek Golf Course-

1. Sales tax issue Ordinance No. 804 will move forward with 1<sup>st</sup> Reading Jeff Ommert stated the motion, seconded by Tony Groshong. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf, absent and not voting were Derek Raburn and Vernita Saylor; none voted no. Motion carried unanimously by City Council Members present for the following Ordinance No. 804:

AN ORDINANCE OF THE CITY OF CAMBRIDGE, NEBRASKA CONTINUTING TO IMPOSE AN ADDITIONAL SALES AND USE TAX OF ONE HALF OF ONE PERCENT (.50%) UPON THE SAME

TRANSACTIONS WITHING THE CITY OF CAMBRIDGE ON WHICH THE STATE OF NEBRASKA IS AUTHORIZED TO IMPOSE A TAX, AND ESTABLISHING ANE FFECTIVE DATE OF APRIL 1, 2025.

- 2. Well #2 repairs and replacements were discussed. Well #2 is not working and not able to water the entire golf course without it. City council members were asked if there is any funding through the city for assistance regarding this matter or if the city could cosign on a loan for financing through the bank. Cross Creek Golf Course received a quote from Downey Well Drilling out of Lexington for \$35,000 to replace the well. City Council stated that the funds were not in this year's budget, however they would be able to cosign on a loan for up to \$40,000. Golf board will negotiate terms at the bank regarding the loan. Tony Groshong stated the motion, seconded by Jeff Ommert to cosign for financing to replace well #2 at Cross Creek Golf Course. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf, absent and not voting were Derek Raburn and Vernita Saylor; none voted no. Motion carried unanimously by City Council Members present.
- f. Pinpoint Shareholders Notice was reviewed.
- g. League Insurance Government Health Team proposal was reviewed. In order to get better benefits with less deductible it was decided that at this time the city continue with what they currently have as the cheapest was \$4,000 more per month.
- h. Terry provided statement of property value. Mayor David Gunderson will be in contact will Hackel Construction regarding the updated value of the pool for property tax value.
- i. Schaben Sanitation sent a letter regarding an annual price adjust increase of 7.9% for Solid Waste Collection & Disposal Rate. Effective June 1, 2022, however the City has 30 days to act. Ordinance 780 was amended and new Ordinance 803 includes rates with the adjusted increase of 7.9%. 1st Reading Tony Groshong stated the motion, seconded by Mike Harris to. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf, absent and not voting were Derek Raburn and Vernita Saylor; none voted no. Motion carried unanimously by City Council Members present for the frist reading of Ordinance No 803 as follows:

AN ORDINANCE AMENDING SECTION 7-502, SANITATION DEPARTMENT; COLLECTION BY CONTRACTOR FOR THE CITY OF CAMBRIDGE REVISED MUNICIPAL ORDINANCES 2020; REPEALING ORDINANCE NO. 780; REPEALING ANY ORDINANCES IN CONFLICT; SETTING EFFECTIVE DATE.

- j. Jessica Fisher for Tri Valley Health System –Annual Health Fair will be June 17, 2022 at the Community Building from 7 a.m. 9 a.m. Tri Valley Health System enjoyed hosting Hackel construction during their stay at the plaza.
- k. Ambulance EMT John Kutnik reported that the ambulance is in manufacturing and final touches on design are being done. Projected date for completion should be the week of July

17. John has been working with the Department of Health and Human Services and Nebraska grant money for items such as new monitors.

Jeff Ommert stated the motion, seconded by Mike Harris, to adjourn the City Council meeting at 7:55 p.m. Voting yes were Tony Groshong, Jeff Ommert, Mike Harris and Kevin Banzhaf, absent and not voting were Derek Raburn and Vernita Saylor; none voted no. Motion carried unanimously by City Council Members present.
