Kevin Banzhaf stated the motion, seconded by John Kutnink to approve items listed under the consent agenda. Voting yes were Kevin Banzhaf, Nora McGowen, Mike Harris, Jeff Ommert, John Kutnink and Vernita Saylor; none voted no. Motion carried unanimously.

Melissa Jackson was here to give Cambridge Economic Development Board report. Economic Development Board moved to approve board members to include people that live in the city limits, people that reside in the 69022 zip code or people at the discretion of the Economic Development Board President. Economic Development Board with review bylaws and update at their next meeting.

Mike Tomlin reported the city generated today for NPPD because there was a couple units down. Mike reported that only one meter froze up and there was a water leak on the west side of town that was repaired.

Courtney Stanton reported Midwinter Conference dates are February 26th and 27th, if any council members want to attend registration needs to be completed by February 8th. Sales Tax received in January 2024 was in the amount of \$37,083.58.

John Kutnink stated the motion, seconded by Jeff Ommert to approve moving forward with the rate study with JKEC. Voting yes were Kevin Banzhaf, Nora McGowen, Mike Harris, Jeff Ommert, John Kutnink and Vernita Saylor; none voted no. Motion carried unanimously.

Del Schoenfish was present to discuss and request financial help for the Cambridge Senior Center. Vernita Saylor and Jeff Ommert are on the committee for the Senior Center. Vernita reported 2 stoves need to be replaced, water heater needs replaced, payroll taxes and insurance cost almost \$1000.00 and insurance will likely be going up. The Senior Center has only received a few donations and has had a couple of fundraisers. The Catholic Church is having a fundraiser in February. City pays the Senior Center utility bill. Discussion consisted of the city giving money to the Senior Center and the City of Cambridge taking over the operation at some point. Rules and regulations would have to be looked at if a municipality was to take over the operation. The location of the Plaza for Senior Center meals was discussed. The council wants Courtney Stanton to look at the budget to see if there is \$12,000 to give to the Senior Center annually. The budget is already set for this fiscal year. Courtney did report that she did not think there is any room for that expense in the general fund and that it would have to come from another department.
