Pursuant to notice published in the Cambridge Clarion, Thursday January 31, 2020, the Cambridge Planning Commission met for regular meeting convening at 5:00 P.M. Present were Planning Commission Members Vicki Brown, Debbi Runner, and Jason Weiss. Planning Commission Members Mike Smith and Jason Cobb were absent.
